

Museum Fire Flood Projects

BACKGROUND

On July 21, 2019, the Museum Fire broke out in the Dry Lake Hills area just north of Flagstaff within the Coconino National Forest. The fire ultimately charred 1,961 acres, including a significant portion of the Spruce Wash Watershed. Flood modeling subsequently showed potential flood risk to neighborhoods in Coconino County and the City of Flagstaff. Both the City of Flagstaff and Coconino County Flood Control District immediately took extensive measures and precautions to mitigate damage from flood events.

Throughout the summer of 2021, unprecedented rain events impacted the Museum Fire burn scar and caused multiple rounds of flash flooding in Flagstaff neighborhoods. The City of Flagstaff continues to collaborate with both the public and private partners to lessen the impact of flooding in the affected Flagstaff neighborhoods.

PROPOSED STORMWATER RATE INCREASE

Several events since the most recent stormwater rate adjustment have combined to make the current stormwater rate insufficient to meet current and future community needs. These events include post-wildfire flood mitigation needs, critical infrastructure upsizing needs in multiple drainage areas, capital improvement projects, and rapidly increasing materials and construction costs worldwide. In response, the City is proposing amendments to the City Code to adopt new or increased fees related to stormwater service charges.



PROPOSITION 441

Proposition 441 will appear on the November 2022 ballot. If approved by voters Prop 441 would invest \$57,285,000 in City of Flagstaff wildfire suppression, stormwater flood mitigation and wastewater treatment infrastructure. Of the total amount, \$26,000,000 would be invested in stormwater infrastructure to address post-wildfire flooding in the Spruce Wash, including channel and other improvements between Paradise Rd and Route 66.
